
1966, as did his sister Caroline. The author draws on her familiarity with this family business and its archives, having managed the gallery (2006–11). She has written an accomplished tone poem of seventeen chapters, which



outline chronologically the issues that arose in this art business up to 1999. When American art critic Harold Rosenberg (1905–78) reviewed René Gimpel's *Diary of an Art Dealer* for the New Yorker in 1967, he regarded the dealer as the third member of an unholy trinity which he labelled the 'art comedy' – the other two members being the artist as 'culture hero' and the collector as possessor and status-seeker. The text is

generously illustrated with interesting archival photographs and high-quality reproduction of works.

But the book is designed, perhaps, as intended more to be seen than read. Its square format resembles a hefty catalogue and weighing 1.375 kilos is somewhat weighty to hold to read. And, while attractive, its typesetting in 10pt, with block quotes in light grey text, cramps the engaging text. It provides insight into the activities, events and close relationships with artists, clients and patrons that shaped the growth of the Purves's business, one that helped Australians better understand the work of the artists it represented. More's the pity that the memoir which the affectionately regarded Anne Purves wrote never saw the light of day.
